- Consider approving the first reading of Ordinance 182-2025 which is an ordinance for The Municipal Code. A motion was made by Vice-Mayor Jarnagin. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.
- Oconsider approving the location for a pavilion that utilizes the ferry at Riverfront Park. A motion was made by Vice-Mayor Jarnagin to place the pavilion inside the track, near the entrance, with the pavilion parallel with the walking track. The motion was seconded by Alderman Bishop. The voting was unanimous in favor of approving.
- Consider authorizing Maintenance Manager, Donnie, to spend a maximum of \$10,000 for the materials & welding labor to build the pavilion at Riverfront Park, 110-44400-941. A motion was made by Alderman Mierek. The motion was seconded by Vice-Mayor Jarnagin. A roll call vote was obtained and was unanimous in favor of approving.
- Consider designating members for the 2026 CDBG Committee to include Alderman Bishop, Alderman Collier, Police Chief Hammonds, Recorder Megan Gentry, Teresa Greer, Johnny Greer, & Brigitte Buttry. A motion was made by Alderman Mierek. The motion was seconded by Vice-Mayor Jarnagin. The voting was unanimous in favor of approving.
- Consider authorizing Fire Chief Suthers to purchase Double-Sided Road Sign for Fire Station #2 in the amount of \$720, 110-42200-266. A motion was made by Alderman Bishop. The motion was seconded by Vice-Mayor Jarnagin. A roll call vote was obtained and was unanimous in favor of approving.
- Oconsider authorizing Police Chief Hammonds to apply & manage the Main Street Beautification Grant. A motion was made by Alderman Mierek. The motion was seconded by Alderman Collier. The voting was unanimous in favor of approving.
- Consider authorizing Police Chief Hammonds to apply & manage the Northfolk Southern Security Grant. A motion was made by Vice-Mayor Jarnagin. The motion was seconded by Alderman Collier. The voting was unanimous in favor of approving.

- o Consider authorizing Megan Gentry, Recorder, to apply & manage the 2025 Health Built Environments Grant. A motion was made by Alderman Bishop. The motion was seconded by Alderman Mierek. The voting was unanimous in favor of approving.
- Consider authorizing Mayor Graham to sign the memo for the Town to participate in the zeromatch option for ARP Contract 2022-8363. A motion was made by Alderman Bishop. The

motion was seconded by Alderman Collier. A roll call vote was obtained and was unanimous in

favor of approving.

Onsider approving Resolution No. 161-2025 which is a resolution to increase the threshold over which public advertisement and sealed competitive bids or proposals are required to \$20,000. A motion was made by Alderman Collier. The motion was seconded by Vice-Mayor Jarnagin. A roll call vote was obtained and was unanimous in favor of approving.

o The Board acknowledged that the Town received approval to issue capital outlay notes from the

Comptroller's Office to purchase the 2025 Ford F450.

A motion was made by Vice-Mayor Jarnagin to approve the increased expenditure of \$215.28 monthly for AFLAC Short-Term Disability, totaling \$912.34 per month. The motion was seconded by Alderman Mierek. A roll call vote was obtained and was unanimous in favor of approving.

A motion was made by Alderman Collier to make the appropriate Budget Amendment in the amount of \$460 to 110-44400-266 and to authorize Maintenance Manager Donnie Morrison to purchase the items needed to repair the Riverfront Park Bathrooms floors. The motion was seconded by Vice-Mayor Jarnagin. A roll call vote was obtained and was unanimous in favor of approving.
